

OFFICIAL RULES

NO PURCHASE NECESSARY. Who May Enter: The Vulcan Combi Oven Thanks Give Away (“Sweepstakes”) is a promotion open to all residents of the fifty United States who have reached the age of majority and are employed by a K-12 school foodservice operation. All federal, state and local laws apply. Void where prohibited. Sweepstakes sponsored by Vulcan, a division of ITW Food Equipment Group LLC, 701 South Ridge Avenue, Troy, Ohio 45374 (“Sponsor”).

Deadline: The Sweepstakes begins on July 15, 2014, at 12:00 noon EDT and ends on November 19, 2014, at 11:59 p.m. EST. To be eligible for prize drawing, all entries must be received by Sponsor no later than 11:59 p.m. EST on November 19, 2014. Entries that are incomplete, defective, altered, illegible, mutilated, forged or irregular in any way, or are not in full compliance with these Official Rules, are void.

To Enter: Participants may enter the Sweepstakes by submitting an online registration at www.vulcanequipment.com/ABC. Participants must complete the online registration information, including designating a school or district. Employees of Sponsor, its affiliates, subsidiaries, sales representatives, retailers, advertising, promotion agencies, and their immediate families are not eligible. **Registration is limited to one entry per designated school or district.** By entering, participant represents that they have the permission and/or consent of their designated school or district to enter the Sweepstakes.

Selection: The drawing will be held on November 20, 2014. One entry will be randomly selected by an authorized representative of Sponsor and the school or district that is designated on the selected participant’s registration will be deemed the “Winner.” Odds of winning will depend upon the number of qualified entries received. Participants need not be present at drawing for their entry to win.

Prize: Winner will receive one (1) Vulcan ABC7 Combi Oven, seven (7) Wire Racks, Stand and Filter (Estimated Retail Value: \$19,992). Prize will be delivered to Winner’s place of business listed on the winning registration or to another business location specified by Winner, so long as that location is in the continental United States. In the event the Winner is identified as an individual on the registration, prize will be awarded to Winner’s employer at the address listed on the registration. Other restrictions may apply.
